Sunrive Cove Marina is seeking permission to proceed with the refurbishment of existing P Dock.

P Dock is 23 years old and in need of maintenance. P Dock currently has 26 uncovered slips with concrete decking and the patios are located on the main walk of the dock.

The finished product would have 26 covered slips with patios located at the front of the slip. The dock will stay in the same footprint as before apart from the roof.

Repairs and upgrades include:

- Replacement of the attenuator wall.
- Replace floatation
- Adding 24ga split roof to allow for wind load.
- Adding additional winches to reinforce anchoring for roof wind load.
- Replacing concrete pavers.
- Updating the electrical system from shore to slips.
- Replacing bridge, dock landing and shore landing (raising elevation above high-water flood plain by 2')
