This is a contract for services with Pencor Construction, LLC of Alpharaetta, GA, to renovate the Hall County Courthouse 1st floor Jury Assembly Room in the amount of \$684,075.00. Staff recomends awarding Pencor Construction, LLC the competitive Invitation For Bid #031-44. Thirty-four (34) bids were sent out, and only five (5) responses were received. Pencor was the low bidder among five (5) bidders who responded to the Invitation For Bid.

The bid from Crown Service Contractors of Gainesville, GA was disqualified because of insufficient documentation in its bid submission. Addendum 3 - Revised Exhibit C (cost proposal) was posted to the County's website, but Crown Service Contractors failed to include this in its bid submission which prevented an accurate evaluation of its bid. CDC Design, Inc of Canton, GA and Tipton Construction of Gainesville, GA submitted a "no bid" in response to the Invitation For Bid.
