Work Session Date: 02/19/24 Voting Meeting Date: 02/22/24 **Executive Summary: Presenter:** CHCODD **Recommendation:** Court Administration recommends approval. **Purpose of Request:** History: It has been many years since the last adjustment by the Grand Jury and Approve the Hall County Grand Jury's increased expense allowance Hall County Commission. Traverse jurors are currently paid \$40 per day. of traverse juror's pay in Superior and State Courts, effective March The Fall Term of the Grand Jury voted to increase the pay to \$50 per 1, 2024. day.

Facts and Issues:

Options:

OCGA § 15-2-7 provides that the first grand jury impaneled at the fall term of the superior courts "shall fix an expense allowance for trial and grand jurors in superior courts of such counties for the next succeeding year not to be less than \$5.00 nor to exceed \$50.00 per diem."

On October 3, 2023, a Hall County grand jury fixed the traverse juror compensation at \$50 per day for calendar year 2024, representing an increase from the 2023 rate of \$40 per day. The increase will be effective March 1, 2024 "subject to the approval of the governing authority of the county" pursuant to OCGA § 15-2-7(b).

Based on the Clerk's reporting of efficiencies with their new software and revised strategies to calling in jurors, no budget adjustment is necessary in FY2024.
