Purpose of Request:		History:		
Approve the sole source purchase of two (2) Lucas Chest Compression Systems and two (2) Stryker Ambulance Stretchers for Fire Rescue to Stryker Medical of Chicago, IL in the amount of \$89,514.22.		In an effort to maintain continuity, the department standardized to the Lucas compression system by Stryker for mechanical CPR devices. The department currently has 21 units in service. All employees are trained on this unit. This also allows for more efficient inventory as the department does not have to stock multiple brands of supplies needed.		
Facts and Issues:		Options:		

Fire Rescue is replacing this equipment, (2)-Two LUCAS devices and (2)-Two Stryker Stretchers. This will allow Hall County Fire Rescue to continue providing the safest and optimal care possible. These devices will be replacing other units that have met their service expectancy.
