Purpose of Request: Approval and authorization for the Chairman to execute an agreement between the Georgia Department of Transportation (GDOT) and Hall County concerning support for lighting at a potential roundabout located at intersection of SR 211 (Old Winder Highway) and Union Church Road. Commission District 1.		History: Project construction is currently programmed for 2030 and as part of plan development, GDOT is requesting Hall County to approve lighting support for the roundabout.		

Facts and Issues:

Options:

The Georgia Department of Transportation is currently developing plans to widen and reconstruct State Route 211 (Old Winder Hwy.) from SR 347 (Friendship Road Road) to SR 53 (Winder Hwy.) in southern Hall County. A roundabout may be proposed for the intersection of SR 211 (Old Winder Hwy.) and Union Church Road / Reveille Parkway within this project. P.I. No. 0007233

The support agreement stipulates that after project completion and acceptance, Hall County will provide for the repair, maintenance and energy required for operation of the lighting for the intersection. there is currently no projected completion date but Hall County would need to budget for the monthly utility costs at the time.
