Purpose of Request:

This is an addendum to the IGA signed by Hall County and the City of Gainesville in 2021, agreeing to allocate an additional \$3.2 million of SPLOST VIII funding for construction of the Airport Connector trail of the Highlands to Islands trail network. The additional funding shall be disbursed no later than 150 days from the execution of the addendum.

Facts and Issues:

The Airport Connector has been identified by the Highlands to Islands Trail Committee, comprised of Hall County, Gainesville, Oakwood, Flowery Branch, the GHMPO and the Vision 2030 Trail Committee, as a priority connector for the Highlands to Islands Trail. Gainesville will bid out the construction of the project and will make Hall County aware of any bid or rebid decisions to allow for review and comment. Gainesville has also agreed to consider the use of inmate labor where savings are evident.
