3. Fully adhere/Fasten Isocyanurate insulation at decking.
4. Install an 1/2 inch prime dens deck at prepared areas.
5. Install 1/2 inch tapered crickets between the drains and end walls.
6. Fully adhere a 60 mil white polyester reinforced TPO roof membrane to newly installed insulation.
7. Install all perimeter flashings and details per manufacturers recommendation.
8. Remove and dispose of all coping at perimeter walls and install new Kynar coated metal coping at removed areas.
9. Upon completion furnish Owner, Manufacturer's Twenty (20) Year Warranty.
