To approve the Resolution consenting to the de-annexation from the City of Lula of approximately 1.11 acres of improved real property located at 0 Old Cornelia Highway, Lula, GA and authorize the Chairman to sign the Resolution subject to the review and approval of the County Attorney.

On February 21, 2022 the City Council of the City of Lula voted unanimously to approve the de-annexation of the tax parcel at issue, and said vote is reflected in the minutes of the City Council. On October 9, 2023, Lula's City Attorney wrote to the property owner stating that the City of Lula needed a resolution by the County consenting to the de-annexation of the property in order for the City to notify the State of Georgia of the de-annexation. On February 14, 2024 the property owner wrote to Hall County's Planning and Development Department requesting the County's consent to the de-annexation and at that time he submitted sufficient documentation to support his request.

The owner wishes to de-annex this parcel from the City of Lula so as to incorporate it into the larger tract of land which is in unincorporated Hall County.
