Negotiations have been 1162100), regarding Parcels 1, 3, and 7, presently owned by DANJI, unsuccessful to date. Condemnation is necessary in order to comply with LLC. the timeline for the construction of the project.

The White Sulphur Road Realignment Project involves the creation of approximately 0.75 miles of commercial roadway and the closing of the current railroad crossing near Cagle Road.
