Forty-eight (48) bids were sent out, and only four (4) responses were received - one of which, Synergy Industrial Services, LLC of Atlanta, GA submitted a "no bid".

Additionally, Current Edge Solutions, LLC of Savannah, GA was the low bidder; however, they are not within 100 miles as stated in the IFB subsection 1.2.B. or the service zone. (The installation/service center must be located within 100 miles of Hall County, GA.)
