Approval and authorization for the Chairman to execute a resolution accepting 3.535 acres of improved real property known as 1280 Athens Street, Gainesville, GA, deeded to the County by the Gainesville and Hall County Development Authority for access to Butler Park, and to authorize the Chairman to execute any and all documents necessary to effectuate the transaction, subject to the review and approval of the County Attorney.		The property was formerly owned by Hall County. It was deeded to the Development Authority in February of 1998 and a Lease Agreement was executed by Hall County and the Development Authority on February 1, 1998 whereby the parties would work together to build facilities on the property and the County would lease the property from the Development Authority. The Development Authority has now deeded the property back to the County as required by Section 10.2 of the Lease Agreement via a Limited Warranty Deed dated March 19, 2024.	
Facts and Issues:		Options:	

The County seeks grant funds for the construction and improvement of Butler Park. The Property lies along Athens Street near Butler Park and all visitors to Butler Park must access the Park through the Property. In order to obtain the grant funds from the State of Georgia, the Butler Park tract must be subdivided into its own separate tract. In order to subdivide the Butler Park tract, the City requires road frontage/access. Acceptance of the deeded Property will allow for the frontage/access needed to comply with the City's code.
