EXECUTIVE ORDER

A virtual hearing was scheduled to be held in the above referenced matter on October 26, 2023 before the undersigned Hearing Officer. The purpose of the hearing was to provide the Respondent an opportunity to contest the charges of violations of O.C.G.A. §16-12-35 and GLC RU 13.1.16 (1) based on cash payouts for play of Coin Operated Amusement Machines (COAMs) to undercover officers with the Hall County Sheriff's Office between September 1, 2023 and September 30, 2023.

Based on the no contest plea¹ submitted by the Respondent, I find the Respondent violated O.C.G.A. §16-12-35 and GLC RU 13.1.16 (1) when it redeemed COAM awards by paying cash to COAM players on two occasions between September 1, 2023 and September 30, 2023, and it is therefore

ORDERED that the Respondent be fined an administrative penalty in the amount of \$10,000; it is further

ORDERED that the Respondent's COAM license be REVOKED for a period of two years from the effective date of this Order; it is further

ORDERED that if the Respondent fails to pay the administrative penalty as ordered herein, any subsequent COAM application that may be submitted by the Respondent shall not be considered by GLC until such administrative penalty is paid.

This order shall become effective immediately with the administrative penalty due on the tenth calendar day following the date of service as shown on the certificate of service below.
