Purpose of Request: Approve the award of RFQ/P #45-001 Cagle Road Improvements for Public Works & Utilities to Simpson's Trucking and Grading, Inc. of Gainesville, GA, in the amount of \$3,417,713.14.		History: On April 13, 2023, the BOC approved an IGA with the Georgia Port Authority to provide funding for this project.			
		RFQ/P #45-001 was posted on March 2024 and Purchasing received nine (9) responsive bids.			
Facts and Issues:		Options:			

The Project is located in northern Hall County (County) between White Sulphur Road on the south and State Route 365 on the north, parallel to the Norfolk Southern Railroad. This County road has a rural cross-section with both paved and unpaved portions. The proposed Cagle Road Improvements Project (Project) includes paving the unpaved portion, roadway grading, and stormwater drainage improvements while maintaining the rural cross-section. The project's length is approximately 6,800 ft., designed according to Hall County Public Works standards.

The project is expected to take approximately 12 months.

The funding for this project is a combination of Georgia Ports Authority (GPA) funds, and Georgia Department of Transportation Local Maintenance Improvement Grant (GDOT LMIG) funds.
