**Purpose of Request:**

**Facts and Issues:** 

The resurfacing list that is a part of the GDOT's FY24 LMAR application. Based on the expected funding from LRA the County is only submitting a condensed list that still maximizes the benefit of LRA funds but will allow Hall County to utilize the most recent road ratings for the FY 25 Resurfacing List.

On March 15 2024, GDOT provided guidelines for additional funding that is being administered through the LMIG application system.
