PROJECT DESCRIPTION

The Hall County Public Works Department for the Hall County Sheriff's Department is requesting Task Order bids for the construction of a new driveway from the upper parking area of the Hall County Government Center parking lot to the lower Sheriff's parking lot.

The Scope of Work is the construction of a new 270-foot driveway to include 20-foot asphalt drive with 2-foot concrete curb and gutter and all site prep, drainage pipes, storm sewer, and structures indicated on the plans attached hereto as Attachment 1 – Scope of Work and Attachment 2 – Stamped Drawings.






