Approve the award of IFB #014-45 New Tires, Related Parts and Services for various County departments to Kesler Tire Service, Inc. of Gainesville, GA and Harrison Tire Service of Gainesville, GA. The estimated annual cost is \$473,935.00.

Facts and Issues:

This is year one (1) of a possible five (5) year contract.

Fire Rescue, Sheriff, and Road Maintenance all reviewed the bid tabulation and agreed to award to Kesler Tire Services and Harrison TIre. In the past, Southern Tire Mart was part of the tire and related parts and services contract. However, each departments had issues with them not being able to provide alignment services when purchasing new tires. Regular sized tires would need to be ordered delaying service and vehicles being out of commission causing issues for departments with limited resources. Southern Tire provided good service when in stock items were needed but it was requested not to award to them at this time. Kesler Tire Services and Harrison Tire both held the previous contract and are vendors in good standing with the County.
