**Whereas**, with both parties agreeing to the extension as stated and therefore, the above numbered contract is hereby changed as follows:



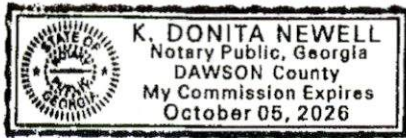
