Purpose of Request: Approve the renewal of the annual contract for RFQ/P #43-004 Sewer System Operations Service for Public Works & Utilities to ClearWater Solutions, LLC of Auburn, AL. The estimated annual cost is \$974,841.00.

History: This bid was awarded to ClearWater Solutions, LLC, in April 2022 for FY 2023.

Facts and Issues: This is year three (3) of a five (5) year contract. ClearWater Solutions, LLC is in good standing within the County. As part of the contract, Clearwater will perform a service to rate the condition and inventory of the County's existing sewer lines over the five-year contract period.

Options:

There is potentially a 15.2% price decrease for the contract for FY25. This is due to removing their coordinating power bills from the scope. Hall County Sustainability officer will perform
