### **SCOPE OF WORK**

See attached Addenda.

The Scope of Work shall include removing and replacing the storm sewer, removing and replacing the roadway, removing and replacing a portion of a residential driveway at 3275 Lake Seminole Place residence (and providing temporary access to the residence), and traffic control.

- Demolish and dispose of existing infrastructure: storm sewer pipe and headwalls, curb & gutter, asphalt and concrete paving.
- Remove and dispose of obstructing trees and other vegetation.
- Proactively mitigate utility services as necessary to nearby residences to minimize utility service disruption(s).
- Replace 6-inch concrete drive apron.
- Relocate mailbox for 3275 Lake Seminole Place in a manner and location reasonably accessible by the US Postal Service.
- Locate underground utilities.
- Provide and install the following:
  - Fencing for silt, tree saving, and public safety.
  - Rip rap as necessary.
  - Two (2) 72-inch precast headwalls.
  - 24-inch by 12-inch by 6-inch high back curb & gutter
  - GAB driveway detour for 6275 Lake Seminole Place residence.
  - 8-inch GAB, no prime, 2-inch 19mm and 1.5-inch 9.5mm.
  - Bermuda and Fescue sod for yard replacement.

- 173 lineal feet of 72-inch RCP Class 3


