Gallagher Company), insurance program coverages, fees, and third party administrator (TPA) services in the amount of \$1,812,139.00; and authorize the Chairman to execute all related documents.

**Recommendation:** Department recommends the approval of the FY 2025 contract renewal for the Property & Casualty Insurance program, which includes the Gallagher Bassett TPA services and Arthur J. Gallagher risk management fees, authorizing the Chairman to execute all related documents.

#### **Purpose of Request:**

The purpose of this request is to approve the annual contract for the Property & Casualty insurance program for FY 2025. This insurance program consists of coverages for property, general liability, automobile, crime, terrorism & sabotage, excess liability, public officials liability, law enforcement, law enforcement off duty, cyber liability, aviation, AD&D, TPA fee, risk management fees, and actuarial.

Facts and Issues:

#### History:

Hall County has utilized the brokerage services of Arthur J. Gallagher Risk Management Services, Inc., since 2016.

**Options:** 

The total program cost for the FY 2025 plan year is \$1,812,139.00 which is an increase of 16.4%. Some of the lines of business under the Property & Casualty umbrella experienced an increase in premiums due to the claims experience: auto liability (7.1%) increased due to the vehicle replacement cost value and the recent vehicle audit which increased our Total Insured Value (TIV) by 62.8%; and property insurance (11.5%) increase due to the increased property values and an increase in the market rates.

For this renewal there was a minor increase in Off-Duty Liability insurance (4.7%), Terrorism & Sabotage (7.7%); Cyber Security liability saw a decrease of (16.1%) due to our increased training efforts; Law Enforcement AD&D decreased by (3.2%); decrease in Crime Liability (1.5%) and no change in Drone Coverage.

The TPA services experienced a (10.2%) increase.
