Purpose of Request: Approve Change Order #1 under RFQ/P #43-004 Sewer System Operation Services for Public Works & Utilities to ClearWater Solutions, LLC of Auburn, AL, in the amount of \$118,791.00.		<b>History:</b> The FY24 renewal was approved by the BOC May 25, 2023 in the amount of \$1,149,652.00.			
					Facts and Issues:

As part of the contract RFQ/P #43-004 with Clearwater Solutions, and in addition to their operations services fee, Clearwater Solutions was managing Rebatable Maintenance Accounts (RMA) for Repairs and Maintenance, Chemicals and Power expenses as they relate to Spout Springs Water Reclamation Facility and the county's 21 liftstations.

Based on higher than expected expenses and incidents related to repair/maintenance and electrical usage and is tracking to exceed the Rebatable Maintenance Accounts for two(2) of the three(3) accounts before the end of FY24.

These repairs/maintenances are related to clogged lines, damaged backflow preventers, replacing pumps, bearing housings, and seals for downed pumps and an increase in power consumption due to damaged pumps operating inefficiently.
