## **Executive Summary:**

#### **Purpose of Request:**

Approve the ratification of the application for grant funds from the Georgia Opioid Crisis Abatement Trust in the amount of \$888,204 to provide funding for medication-assisted treatment services, case manager salary and fringe benefits for two pre-existing positions, clinical supervision services, treatment provider funds, housing assistance and residential treatment entry fee coverage, medication-assistance training for Treatment Services staff, and peer recovery services for accountability court participants. If awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. There is no match requirement.

#### History:

Treatment Services is the agency umbrella encompassing all accountability court programs in our judicial circuit. Due to our sharing of resources among all programs, we are able to streamline and greatly increase our ability to provide comprehensive treatment services to program participants and the communities we serve. In addition to our General Fund budget, our operations are funded from DATE funds, participant fees, drug testing lab revenue, evaluations revenue, and grant awards. When federal funding ends, we are hopeful that County Commissioners will absorb the grant-funded positions and benefits under the General Fund budget. Additional financial assistance comes from Friends of Recovery, a nonprofit organization formed in 2006 to support Hall County's accountability court programs. Our circuit serves the largest volume of accountability court participants in the state of Georgia and served over 800 participants in 2023.

#### Facts and Issues: Options:

Treatment Services provides comprehensive mental health and drug and alcohol services to high-risk, high-need individuals involved in the criminal justice system. We provide an alternative to incarceration by offering intensive and individualized treatment to those suffering from mental health and substance use disorders. In 2023, approximately 10-15% of participants reported opiates as their drug of choice. Due to the serious lethal consequences of drugs such as Heroin and Fentanyl, it is more important that ever to provide quality services to our participants. Last year, Treatment Services served 838 participants in all of accountability court programs and celebrated the achievements of over 129 graduates. Our Hall County office has over 40 employees and we operate services 7 days per weeks. Our drug testing lab analyzed over 50,000 screens in 2023 and we serve the highest volume of participants than any other judicial circuit in the state.
