Purpose of Request:

History:

Hall County has taken all steps necessary to place a Referendum before Hall County Voters concerning approval of a Transportation SPLOST. This Resolution authorizes the special election on the Referendum.

Facts and Issues:

Options:

If the Voters approve the Referendum in November, the Transportation SPLOST will take effect on April 1, 2025.

Because all Municipalities approved a Transportation SPLOST Intergovernmental Agreement, the Resolution calls for a 6-year Transportation SPLOST Program.
