The request before you is the request of Andy Carter for a Use Subject to County Commission Approval to allow a 2-lot residential subdivision. This item is located within Commission District 1.

At their June 3, 2024 meeting, the Hall County Planning Commission voted to recommend approval with five (5) conditions (5-0).

Staff recommendation: **Approval, with conditions,** as the proposed request is consistent with the Residential future land use classification within the Comprehensive Plan.

There were no comments submitted in advance of the Planning Commission meeting and no one spoke during the public hearing.

Planning Commission Conditions:

- 1. The property shall be developed in accordance with the site plan dated April 1, 2024 and as described in the project narrative submitted on April 5, 2024, modified as necessary for compliance with conditions herein and development standards enforced at the time of site plan approval.
- 2. The property shall be subdivided into a maximum of two (2) residential building lots in accordance with the requirements of the Residential-I (R-1, 17.60) zoning district as detailed in 17.240 (area and setback requirements).
- 3. The following statement regarding the potential impacts of agricultural operations in the area shall be made a part of any plat recorded on the property:

"Owners, occupants, and users of property shown on this plat are hereby informed of the impacts associated with normal farming practices which may take place on adjacent and nearby property including, but not limited to, noise, odors, dust, the operation of machinery of any kind, the storage and disposal of manure, and the application of fertilizers, herbicides, and pesticides. Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."

- 4. No variances or development exceptions are granted as part of this request that are not explicitly granted by Board approval. The development shall be compliant with the Official code of Hall County.
- 5. All conditions of zoning shall be made part of any plats created for the property.
