

Hall County, GA Investment Summary

Solution Overview:

Marathon Health is proposing a few models for Hall County's evaluation to provide employees, spouses, and dependents convenient access to healthcare. Based on the population size, occupational health scope, utilization data provided in the RFP, and our experience in the public sector, we recommend operating the health center at the base 48 hours per week; however, we are open to discussions with the County based on their current experiences to determine what solution is most fitting for your specific goals and objectives.

We have provided the following options for the County's evaluation:

- 48-hour model Physician (MD) led: We understand the County may desire to
 maintain having a physician as a part of the health center staff. While the MD is only
 reflected in this 48-hour model, this can be replicated with additional hours of
 operations if desired. We have prepared an ROI analysis to reflect this staffing model
 see attached ROI Analysis for MD-led model.
- <u>48-hour 52.5-hour model Nurse Practitioner (NP) led</u>: Based on Georgia regulations and the partnership with your full onsite pharmacy, a nurse practitioner is able to practice with a collaborating physician oversight. We have this model in operation at many of our health centers across the county. The nurse practitioners that we hire are expected to practice to the top of his or her licensure and therefore can perform majority of the services a physician would provide. We have prepared an ROI analysis to reflect this staffing model see attached ROI Analysis for NP-led model.
- <u>58.5-hour model Nurse Practitioner (NP) led</u>: This model mirrors the previous APP led model (listed above) accounting for additional hours of operation.

We look forward to the opportunity to collaborate with the Hall County team to build the most meaningful solution for both you and your members.

Pricing Assumptions

- The onsite health center pricing is based on 1,388 eligible employees and 3,190 total eligible members. Marathon Health reserves the right to revisit the pricing and staffing model if the eligible population exceeds 110%.
- Marathon Health reserves the right to revisit the staffing costs, as part of the total annual service fee, if the actual salaries of the hired staff exceed 10% or more of the assumed salaries included in the proposed pricing.
- Standard contract term: 3 years and includes a 5% annual fee increase each year.
- Externally processed labs and vaccines will be charged to the client monthly at our cost as incurred.
- Staffing model is based on 65% employee engagement assumptions for year one.
- The one-time Implementation fee includes the recruiting and training of new staff positions, initial medical supplies and equipment, eligibility file set-up, IT and site set-up, and Project Management travel.
- The above proposed pricing is valid for up to 180 days.

Updated Terms 7/2/2024:

#1: <u>Contract Terms</u>: Marathon Health accepts the 1-year contract terms with four 1-year renewal options totaling to a total a 5-year contract before a new contracting period begins. Marathon requests a 180-day notice period prior to the contract end date to be included. This allows for staff to find new employment following the end of the Marathon Health contract period.

#2: <u>Unfilled Staffing</u>: We'd like to propose inclusion of language regarding a potential payment based on unfilled staffing hours:

- 0-7 Unplanned Absences per provider: no penalty
- 7-10 Unplanned Absences per provider: \$500 per day unfilled
- More than 10 unplanned absence per provider: \$750 per day unfilled

Unplanned Absences are defined as each workday where notice was given within less than 24 hours and not able to be backfilled. Virtual care may be utilized for backfill for 1st day of absence, and such coverage shall not be considered an Unplanned Absence. In-person backfill may be utilized at any time, and such coverage shall not be considered an Unplanned Absence. This would be reviewed on an annual basis, as needed, and credited at the following years' first month payment.

#3: Annual Escalator: Marathon Health agrees to reduce the annual escalator to 4%.

#4: Additional Terms:

- Year One annual fixed fee to \$1,619,276 for MD-led model.
- Implementation fee has been reduced to \$36,223
- Annual fee includes all technology, patient portal, wellness portal, reporting capabilities, referral services, and more.
- The only additional fees outside of listed above:
 - Labs (as consumed) passed-through directly to Hall County
 - Any furniture needs will be audited during implementation, and we will work with the County on getting the necessary additions purchased based on what is removed from the prior vendor and/or the County has available. Any needed items will be a pass-through cost.
