As you know I represent Terry Graham and his wife regarding the pending rezoning on Azelia Drive.

As we have discussed with you in the past, we believe that this development would make more sense with a roadway and cul-de-sac to access the majority of the lots. This would seem to address concerns about emergency access as well as minimize the impact to the neighbors and address faire/emergency access concerns.

I have attached a the sight plan with a cul-de-sac overlayed as an example of how simple this could be. I hope that you and the rest of the commission will consider this as a condition.

As a reminder, we would request at a minimum the following additional conditions:

- 1. Any additional road right of way required for development, including but not limited to, right of way for road improvements, emergency access or turnarounds in conjunction with the development of the subdivision must be provided by the land owner of the development. No right of way will come from neighboring property owners.
- 2. The land owner/ developer must provide a comprehensive stormwater management plan to Hall County before or at the time of subdivision of the first lot.
- 3. There will be an access road to access the Lots off Azelia drive. (OR in the alterative) A maximum of three (3) driveways permitted off of Azelia Drive to access the seven (7) flag lots.
- 4. Any material changes to the development plan as submitted will require approval of County Commission.
- 5. Storm Water The developer must provide a Hydrology/storm water plan, acceptable to the County before any subdivision of lots is permitted.
