#### Purpose of Request:

Approval and authorization for the Chairman or Vice-Chairman to execute an Intergovernmental Agreement between Town of Braselton and Hall County regarding Sanitary Sewer Billing, subject to review and approval by the County Attorney.

#### History:

Hall County and Gainesville have a similar IGA in place to allow City of Gainesville to bill for Hall County sewer customers on their water bills.

#### Facts and Issues:

There are areas in Hall County sewer service district which are provided public water by the Town of Braselton. This agreement directs Town of Braselton to bill and collect for the monthly base sewer and commodity charges on the water bills of those customers who are Hall County Sewer customers.

#### Options:

This agreement will result in approximate annual revenue totaling \$ 72,000 each fiscal year.
