#### Purpose of Request:

Approve the one-way street conversion on Spring Street between Highland Street and Victory Street, within the New Holland subdivision, in order to help reduce traffic volumes and improve safety as a result of the connection to the Publix Shopping along Victory Street.

With the new Publix shopping center project being constructed on Limestone Parkway, an access road was created on Victory Street to access Jesse Jewell Parkway. At the request of area citizens, Hall County Public Works has evaluated and recommends a one-way traffic pattern on Spring Street to minimize vehicle traffic and maximize safety.

Once completed, vehicles will no longer be able to access Spring Street from Victory Street. The one-way direction will be from the intersection of Spring Street at Highland Street to Victory Street. Stop, Do Not Enter, and One-way signs, along with directional arrows on the pavement, will be installed to help direct traffic.
