### **Purpose of Request:**

Approval and authorization for the Chairman to execute a lease amendment between Hall County and the United States Department of Agriculture for lease of the facility located at 734 E. Crescent Drive in Gainesville, and authorization for the Chairman to execute any and all documents necessary to effectuate the lease, subject to review and approval by the County Attorney.

#### Facts and Issues:

The previous lease agreement outlined a lease fee of \$2,566.00/month for an annual total of \$30,792. The current lease agreement includes a lease fee of \$3,690.00/month for an annual total of \$44,280.00. This amount is calculated by applying the inflation rate to the amount charged in 2013. The extension is effective Dec. 1, 2024.

#### History:

This is a renewal of a current lease with the United States Department of Agriculture for the space it currently shares with the University of Georgia's Extension Agency, located behind the Farmer's Market near Hall County Fire Station 7. The most recent version of this lease on file was signed in 2013.
