Purpose of Request: The purpose of the request is to ensure there is documented instruction as to how Juvenile Court Judges are paid and when any cost of living increases given to Superior Court Judges by the state are then given to Juvenile Court Judges.		History: Unlike state court judges, the solicitor general and magistrate judges, local legislation and state law do not outline with certainty how juvenile court judges salaries are set other than to say they "shall be set by the superior court of the circuit in which the judges serve with approval of local governing authories." The state law which speaks to juvenile court judges' salaries also is unclear regarding when any cost of living increase given to superior court judges would go into effect for juvenile court judges. Creating a standing order which speaks to these issues is the recommendation of both legal counsel and Administration in order to clear up any confusion going forward.				

Options:

Facts and Issues:

The increase for Juvenile Court Judges was originally scheduled to begin Jan. 1, 2025 given that there is some discrepancy in both previous standing orders and the ACCG Guidebook as to when a COLA is to begin for Juvenile Court Judges. Vacancy allowance will provide for the increases to be retroactive to July 1, 2024 and that is the request from Courts.
