Purpose of Request:

Approve the award of RFQ/P #45-015 Roll-Off Solid Waste Hauling Services for Public Works & Utilities to North GA Excavating Group, LLC of Lula, GA. The estimated annual cost is \$750,000.00.

History:

Previously, IFB #016-45 Roll-Off Solid Waste and Recycling Hauling Services was awarded to the lowest cost bidder, Blue Level Services, LLC of Clarkesville, GA, in the amount of \$812,323.72, for both Solid-Waste and Recycling services on Agenda Item #196/2024.

Facts and Issues:

Blue Level Services, LLC of Clarkesville, GA failed to deliver the required amount of CDL drivers as contracted since beginning the service July 1, 2024. A thirty (30) day Notice-to-Cure was issued to Blue Level to give them the opportunity to correct the issue, which they failed to do, causing the County to then issue a Notice-of-Default to them. The decision was made to separate Solid-Waste and Recycling Hauling into two (2) separate contracts. The RFQ/P #45-015 is just for Solid-Waste Hauling and the recommendation is based on the overall highest scoring bidder, North GA Excavators of Lula, GA, by combining both Technical Qualifications and Cost scores.
