I continue to oppose the applicant's rezoning request on J M Turk Rd, Flowery Branch, Ga, based upon the proposed density. The Planning Commission has rightly recommended denial of this application because it exceeds the Hall County Comprehensive Land Use recommendation for a maximum of 2 units per acre. I also note this communities' solid opposition to this plan because it is inconsistent with homes built on this road over the past 25 years.
