Dear Planning Commission,

The applicant for **0**, **4611**, **4627 Guth Road & 0**, **4561**, **4613 J M Turk Road & 4590**, **4601**, **4610 Stanley Road** to rezone from Agricultural Residential III (AR-III) to Planned Residential Development (PRD) for a 256-unit residential development has provided several updated and supplemental items to the application as detailed below:

- 1. An **updated narrative** providing the following information:
 - a. Construction entrance location
 - b. Townhome density
 - c. Maximum garage door coverage (single-family & townhomes)
 - d. Entrance monument sign location and rendering
 - e. Amenities to include: Swimming pool, pool house, pickle ball courts, HOA-maintained community garden.
 - f. Constitutional and Ante Litem Notice
- 2. An updated site plan depicting the following information:
 - a. Note to reflect the construction entrance and staging area in the proposed Guth Road emergency access turnaround.
 - b. Note to reflect the inclusion of an HOA community garden
 - c. Staggered layout of townhomes with no more than 6 attached units
- 3. An updated Trip Generation Study providing the following information:

- a. 153 morning peak hour trips (reduction of 35 trips)
- b. 220 evening peak hour trips (reduction of 40 trips)
- c. 2,284 total trips (reduction of 516 total trips)
- 4. A **comparison chart** of the new proposed details (HZON24-0020) to the previously submitted application (HZON23-0041) as well as comparing the project to a recent rezoning request that came before the Planning Commission and has not yet been heard by the Board of Commissioners
- 5. A **rendering** of the proposed monument sign
