Purpose of Request:

Approve the ratification of the application for the US Department of Transportation Federal Railroad Administration's Railroad Crossing Elimination Grant Program to provide funds for the project planning phase to relocate the Navajo Circle Railroad Crossing, in the amount of \$319,360.00. If awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related award documents. A match of \$79,840.00 will be required.

Facts and Issues:

The Railroad Crossing Elimination Program provides federal funding to fund highway-rail or pathway-rail grade crossing improvement projects that focus on improving the safety and mobility of people and goods. Relocating the Navajo Circle Crossing will increase safety, decrease traffic in the area, and serve as an overall benefit for Hall County.
