We created the account under her name, no return was filed by the Thompsons under that account number, NOA was mailed, and no appeal was made by the Thompsons. Mr. Thompson filed a return under his name showing the 2021 Mastercraft under his name but did not list a DNR registration number. The boat was added under Mr. Thompson's account, P320639, based on the best information given at the time, NOA was mailed, and again no appeal was made by the Thompsons.
- Both accounts had the bills paid for in full for 2022.
- Mrs. Thompson's account was listed as county district. The estimated refund request is for county only.
