Facts and Issues:

**Options:** 

Refund in the amount of \$1,892.62 for boat owned by Ryan and Elizabeth Thompson. Reporting of boat was duplicated. Unkowingly, Mr. Thompson reported the boat separately from Ms. Thompson, both parties were noticed and paid bills separately.

Duplication was discovered by Mr. & Mrs. Thompson after property tax bills were paid.

The DNR boat registration showed the vessel to be registered to an Elizabeth Thompson.

The boat account was added in Mrs. Thompson's name based on the DNR registration.

Ms. Thompson did not return the personal property reporting form, therefore a value was determined, a notice was mailed and no appeal was filed by Ms. Thompson. Therefore, the valuation was used for billing and bill was paid.

Not knowing that the boat had been assessed under his wife's name, Mr. Thompson also filed a return voluntarily under his name for the same vessel. Mr. Thompson did not list a DNR registration number on his return.

This boat was then added under Mr. Thompson's account, based on his return

A notice of assessment was mailed, and as in Ms. Thompson's case no appeal was made therefore causing this account to also be billed. The bill for this account was also paid.

Both accounts had the bills paid in full for 2022.

The Thompson's discovered the duplication after the bills were paid.
