Purpose of Request: Approve the ratification of the 2025 Judicial Council American	History:	
Rescue Plan Act Grant funding application for the Northeastern Judicial Circuit to address case backlogs in the amount of \$1,120,739.00, and if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. No cash or in-kind match is required.	The Northeastern Judicial Circuit was awarded a total of \$1,680,497.00 in 2022; \$2,500,000.00 in 2023; and \$749,692.00 in 2024.	

Facts and Issues:

Options:

Governor Brian P. Kemp has allocated up to \$110 million in American Rescue Plan Act funds to address backlogs of court cases, prioritizing cases involving serious violent felonies. The Judicial Council of Georgia and its Administrative Office of the Courts will administer up to \$96 million in grants to authorized classes of court, prosecutors, and related agencies. The Ad Hoc Committee on American Rescue Plan Act Funding will exist from the date of October 28th, 2021 until September 30, 2026, unless otherwise extended. This item ratifies the application submitted by the Northeastern Judicial Circuit on October 16, 2024 seeking funds to be awarded in calendar year 2025. We also have a planned rollover from CY2024 ARPA grant of approximately \$549,681 to cover all personnel expenses for one year as well as other expenses related to the backlog of cases. We are requesting the ARPA grant fund the following positions which are currently paid out of restricted funds: (1) staff accountant, (1) operations coordinator and (1) case manager. We are requesting ARPA continue to fund the following positions *currently* paid out of ARPA grant funds: (1) court reporter, (1) administrative assistant -District Attorney, (1) administrative secretary - Pretrial Services, (5) bailiffs, and (1) case manager. Lastly, we are requesting one net new position be funded by ARPA in 2025 which will increase position control: (1) judicial assistant. We are also requesting three positions for Dawson County.
