**Subject:** Using the Round About will be the safest and most efficient way to handle traffic at Lights Ferry and McEver Road

**Good Morning Team Hall Commissioners:** This concerns the proposed gas station at Lights Ferry and 5820 McEver Road, Flowery Branch

**McEver Road has non-stop, bumper to bumper Southbound traffic during rush hours at the Lights Ferry intersection.**

**With the new proposed Round About there will be fewer gaps in McEver Road Southbound traffic to be able to turn into the gas station from the proposed Northbound turn lane.**

**Someone travelling Northbound will have to idle in the proposed turn lane (greater emissions) for a while waiting for a gap!**

**Then they could misjudge the speed of the Southbound vehicle and cause an accident.**

**Not to mention the other cars idling to do the same thing, also waiting in the center turn lane.**

**Now we focus on the already approved Southbound Exit from the gas station onto McEver.**

**This looks good on paper until you factor in the line of Southbound cars spewing non-stop from the Roundabout.**

**Here again we have cars idling while waiting for a gap to shoot out onto McEver and join the line of SB vehicles.**

**Why are we promoting possible car crashes, idle vehicles?**

**We have a 2.5 million dollar roundabout that will eliminate all of these dangerous situations.**

**Not allowing any access in or out of the gas station from McEver will be the safest and most efficient way to handle traffic.**

**The whole reason the Round About was voted for.**

**Why give the gas station a free pass to avoid all the safety and emissions features the Round About offers?**

**Please omit the already approved Southbound exit and do not allow any curb cuts on the McEver road side.**

**Make everyone wishing to visit the store to use the safe Round About by turning onto the lower traffic count Lights Ferry Road.**
