At the July 5, 2022 the Planning Commission voted to table the request with the following comments:

Mr. Braswell listed what was needed from the applicant due to being on the Gateway Corridor Overlay such as a site plan to scale, narrative with architectural standards, along with artist renderings of the structure, type of materials and colors used. Mr. Braswell stated that the public forum would be opened at the tabled meeting date to have all the information presented to the public for accurate comments.

The applicant met with Planning Staff on July 18, 2022 to discuss requirements, but has not submitted any additional information.
