Sardis Creek Park is a 27.6-acre property located at 2991 Antioch Church Road, Gainesville, approximately 1.7 miles from Ga. State Route 53. It is situated at the end of a peninsula on the west bank of the Chattahoochee River arm of Lake Lanier. It includes a boat ramp, parking, picnic tables, and a farmhouse, which predates the lake. The Farmhouse is in good condition and was previously used as a Ranger Station and USACE vacation residence.

Agreement is a 25-year, no-fee lease, similar in nature to existing agreements at Laurel Park, River Forks and Wahoo Creek.

Effective date is July 1, 2025.
