Approve the award of RFP #45-021 Hoschton Master Transportation Plan for Gainesville-Hall Metropolitan Planning Organization (GHMPO) to Keck & Wood, Inc. of Duluth, GA in the amount of \$148.305.00.

Final deliverables from Keck & Wood, Inc. will be due to GHMPO by January 2026, with anticipated adoption by GHMPO at its February 2026 Policy Committee meeting.

Keck & Wood, Inc. had the highest technical score while remaining within the planning grant (PL) awarded amount of \$150,000.00.
