Purpose of Request: Approve the sole source purchase for the repair and rebuild of two (2) engines for two (2) 1999 Caterpillar Motor Graders for Road Maintenance to Yancey Brothers Company of Dacula, GA, in the estimated amount of \$178,010.48.		History: Yancey Brothers Company is in good standing with the County. The two existing Caterpillar Motor Graders were purchased in 1999. Motor Grader 516L has over 5,301 hours of use and Motor Grader 518L has over 6,729 hours of use.			
Facts and Issues:		Options:			

The two Motor Graders to undergo repairs are 516L and 518L. Upon completion, the Motor Graders will be back in service, which will reduce downtime and improve the efficiency of Road Maintenance's operations.

The two Motor Graders were purchased in 1999. The Motor Graders are used to scrape and pull ditches for 60 miles of gravel roads with a total of 149 roads. They are part of the inclement weather program to remove ice/snow as needed. The engines being installed will be certified and will have a 3 year / 5,000 hour warranty. This should extend the life of both Motor Graders 20 years.

Yancey is the authorized dealer and repair center for Caterpillar Equipment.
