WHEREAS, <u>Grove at Rosebud</u>, <u>LLC</u> (principal) is owner of the Subdivision known as Magnolia Bluff Subdivision, which subdivision is shown on a plat prepared by Blue Landworks, Tommy Woodsmall, Georgia Registered Surveyor Number 2767, and

WHEREAS, <u>Grove at Rosebud</u>, <u>LLC</u> (principal) wishes to induce the Board of Commissioners of Hall County, Georgia to approve the street system shown on the Final Plat of Magnolia Bluff Subdivision for recording purposes, and

WHEREAS, <u>Grove at Rosebud</u>, <u>LLC</u> (principal) wishes to induce the Board of Commissioners of Hall County, Georgia to accept the streets shown on the Final Plat of Magnolia Bluff Subdivision for public maintenance (not applicable to private developments); <u>Grove at Rosebud</u>, <u>LLC</u> (principal) and <u>The Service</u>

<u>Insurance Company</u>, <u>Inc.</u>, (surety) agree in consideration of the foregoing,

NOW, THEREFORE BE IT RESOLVED, Grove at Rosebud, LLC (principal) agrees that all construction of the street system of Magnolia Bluff Subdivision will be completed and maintained for fifteen (15) months according to the terms and requirements as shown on the recorded Final Plat and of the Subdivision Regulations in force in Hall County, Georgia.

Grove at Rosebud, LLC (principal), and <u>The Service Insurance Company</u>, <u>Inc.</u>, (surety) agree to the following:

Sidewalks will be completed throughout the entire subdivision as shown on recorded final plat within one

(1) year of signing of said final plat. One inch of "F" mix asphalt may be placed anytime prior to final platting or up to one (1) year after final plat approval. In addition, Principal and Surety agree that if either

the sidewalks, cuts, fills, sub-grades, shoulders, pavement, grassing, storm water management facilities, sewer, or traffic signs in Magnolia Bluff Subdivision are improperly maintained or are found to be defective from faults in design, materials or workmanship as shown on the recorded Final Plat, or as set out in the Subdivision Regulations in force in Hall County, Georgia, then upon demand from Hall County, The Service Insurance Company, Inc., (surety) shall pay the bond amount to Hall County.

### **Terms of Guaranty:**

Grove at Rosebud, LLC (principal) and The Service Insurance Company, Inc., (surety) shall be bound by the provisions of this agreement until a properly authorized letter is received by The Service Insurance Company, Inc., (surety) from Hall County authorizing release of Grove at Rosebud, LLC (principal) and The Service Insurance Company, Inc., (surety) from this Guaranty Agreement.

NOTWITHSTANDING the above provisions, this Guaranty Performance/Maintenance Agreement is hereby issued on November 8, 2024 (Date) and expires on November 8, 2026.

(Date, minimum 24 months from date of issuance), and the Issuer will have no more liability after that date. When the indicated expiration date falls on Sunday or a legal holiday, or for any reason the Issuer is not open for business, the expiration date shall be extended to the next succeeding business day. Jurisdiction for any civil litigation necessary for collection of bond claims hereunder shall be in the Superior Court of Hall County, Georgia.
