A density of 2.77 is not okay.

There is no mention of amenities or 6' wood fence. Also, there are no townhomes in Chestnut Mountain. At times, school traffic completely blocks both south bound lanes of highway 53.

Please consider the following:

1. Locate the 50' buffer with 6' wood fence outside my easement
2. Deceleration lane off 53 start past my easement driveway
3. 30 days after first grade – complete green space and wood fence
4. Add language as to upkeep of green space and 6' wood fence
