LEGAL DESCRIPTION

4159 Cleveland Highway

All that tract or parcel of land lying and heing in Land Lot 26 of the 12th Land District of Hall County, Georgia and being all of Lots 8 and 9 of the J.N. Rogers Subdivision as shown by plat recorded in Plat Book 90, Page 88 of the Hull County, Georgia Plat Records and more fully described on a plat by Dwight Kilby, Georgia Registered Land Surveyor, dated October 28, 2004 entitled "Survey for Stan C Bennett and Charlie Lathern".

BEGINNING at an iron pin located on the Western right-o- way of U.S. Highway 129 which iron pin is located at the Northeast corner of Lot 9 of said subdivision and also located 521.26 feet South of the intersection of U.S. Highway 129 and the centerline of Hunter Road as measured along the Western right-of-way of U.S. Highway 129; thence in a Southerly direction along the Western right-of-way of U.S. Highway 129 the following courses and distances:

South 18° 42' 09" East 78.42 feel;

South 73° 14' 32" West 13.14 feet;

South 18" 43' 39" East 105.17 feet;

North 70° 44' 02" East 12.97 feet;

South 18° 49' 25" East 226 74 feet to a concrete right-of-way monument; thence leaving the Western right-of-way of U.S. Highway 129 South 71° 20' 28" West 537.00 feet to an iron pin;

thence North 23" 53' 02" West 407.30 feet to an iron pin;

thence North 70° 58' 37" East 573.45 feet to an iron pin on the Western right-ofway of U.S. Highway 129 which is the POINT OF BEGINNING
