This is our first time applying for funding through the Byrne SCIP grant.

Treatment Services is seeking grant funding through the BYRNE SCIP Behavioral Health Deflection grant to fund 20 hours of peer support recovery services to Drug Court and HELP Court participants. We will work with our local RCO, J's Place, to expand our current peer services in an effort to promote long-term recovery from substance use and reduce recidivism.
