Beth, per our discussion with Hall County Engineering, we have determined that it is in fact, illegal to re-route the water that currently flows towards Ms. Jill Cooper. There is currently about 20 acres that naturally flows towards her pond. We have to actually keep the same flow that currently exists.

So through the help of Hall County Engineering, we have come up with the following proposed conditions to ease the tensions around potential run-off from the development.

- 1- Have a siltation analysis performed on her downstream pond. This would be pre and post development. Pre development to determine a baseline analysis, then post to determine any change. We would dredge any additional silt that is added during construction. This would require Ms.Coopers approval to enter onto her property.
- 2- Increase the size of the temporary silt pond for construction from 67 cu/yds to 134 cu/yds, doubling the required size under current BMP's.

Please feel free to reach out to me with any questions. Steve and I will be reaching out to Ms. Cooper today to get her opinions on the proposed conditions.
