Please be advised that our office has reviewed the Hall County Planning Commission agenda for the December 16, 2024 meeting. Upon review, we provide the following comments.

NEW BUSINESS

1. [3835 & 3875 Cornelia Highway | Amend conditions of zoning | on a combined 80.03± acre tract located on the north side of Cornelia Highway approximately 2,270 feet from its intersection with Cagle Road | Zoned PID \(GCOD\); Tax Parcels 15007 000095A & 000276 | Proposed Use: Amend site plan and expand uses | ** Commission District 3 | Rochester | DCCM, applicant](#)

- a. **Engineering:** This site may require a stormwater management report should the site plan indicate the proposed development meets stormwater thresholds for impervious surfaces and/or disturbed acreage. Show stream buffer and impervious setback from wrested vegetation not centerline of stream
- b. **Traffic:** No comment
- c. **Utilities:** All sanitary sewer adjustments shall be approved by Hall County Public Works.

2. [3042 Beards Road | Rezone | from Planned Commercial District \(PCD\) to Agricultural Residential III \(AR-III\) | on a 2.50± acre tract on the west side of Beards Road approximately 250 feet from its intersection with Lanier Islands Parkway | Zoned PCD; Tax Parcel 07329 003012 | Proposed Use: Single-family residence | ** Commission District 2 | Tim Mooney, applicant](#)

- a. **Engineering:** No comments
- b. **Traffic:** Driveway will need to meet Hall County driveway regulations. Due to horizontal curves in the area, applicant should verify required sight distance can be at proposed driveway location.

c. **Utilities:** Buford sanitary sewer district

3. **(A) 4767 E Reed Road | Rezone | from Agricultural Residential IV (AR-IV) to Residential I (R-I) | on a 4.07± acre tract located on the southeast side of E Reed Road at its intersection with Strickland Road | Zoned AR-IV; Tax Parcel 15029 000100 | Proposed Use: 5-lot residential subdivision | ** Commission District 1 | Cameron Henderson, applicant**

(B) 4767 E Reed Road | Use subject to county commission approval | on a 4.07± acre tract located on the southeast side of E Reed Road at its intersection with Strickland Road | Zoned AR-IV; Tax Parcel 15029 000100 | Proposed Use: 5-lot residential subdivision | ** Commission District 1 | Cameron Henderson, applicant

- a. **Engineering:** No comment
- b. **Traffic:** An access easement for the existing access to Platt Park across lot 5 to be provided to Hall county
 Driveways will need to meet Hall County driveway regulations
 Recommend a shared driveway for proposed lots 4 & 5 so as to not interfere with access to Platt Park
 Applicant should verify that required sight distance can be achieved along all lot frontages for future driveways
- c. **Utilities:** Hall County Sewer district
 No Sewer service infrastructure nearby.
