Approve the purchase of one (1) Pierce Enforcer 107' Tractor Drawn Aerial (Tiller) truck for Fire Rescue to Ten-8 Fire & Safety, LLC of Bradenton, FL, in the amount of \$2,169,124.00.

History:

Ten- 8 Fire & Safety, LLC has been a vendor of Hall County for over fifteen (15) years and is in good standing with the County.

The County now has a total of twenty-four (24) Pierce apparatus.

Facts and Issues:

This purchase will be made through participating in the NPPGov Consortium Contract #PS20240. The pricing will be valid until February 26, 2025. Ten-8 Fire & Safety, LLC is the sole dealer for Pierce apparatus in Georgia. This purchase will allow Fire Rescue to maintain a standardized fleet and have a certified vendor on contract to complete all work to meet or exceed manufacturer requirements and complete any warranty work.
