#### Purpose of Request:

Approval and authorization for the Chairman to execute an agreement between Hall County and Cedar Grove Landfill, LLC to allow Public Works & Utilities to dispose of sludge waste material from the Spout Springs Water Reclamation Facility into the Cedar Grove Landfill in Barnesville, GA, subject to review and approval by the County Attorney. The estimated annual cost is \$50,000.00.

#### History:

Previously, Hall County had an IGA with Lamar County Regional Solid Waste Authority (LCRSWA) who owns the Cedar Grove Landfill. Cedar Grove Landfill LLC entered into a 30 year management and operations agreement since that IGA was executed. This agreement modifies the agreement to be with Cedar Grove instead of LCRSWA and extends the terms of the contract to February 28, 2030.

The previous agreement with LCRSWA was approved in February 2020 and expires February 2025.

#### Facts and Issues:

Cedar Grove LLC agrees to accept up to 100 tons of sludge per week at its Cedar Grove Landfill at \$75 per ton of sludge desposited.
